## **Festival Report:**

2014-2015 Honors Recital – Thanks, Hilary! Plattsburgh students made up 90 percent of the Honors Recital participation this year. It would be nice for other districts to submit students of all ability levels. Applications and information are on the website.

2015-2016 dates – see calendar on the zone site. Dates will alternate between Livingoods and Plattsburgh Brewing Company. Social hour from 5-5:30, meetings will begin at 5:30 pm. Discussion concluded.

All-County Discussion: There will be an All-County Symphony Orchestra. Mike Nystoriak will be the conductor. 7th - 12th grade strings, 10th - 12th grade winds and percussion. The ensemble will need saxophones and euphoniums, but not e-flat or alto clarinets.

Patrick Towey has found a conductor named Phil Aguglia from Kenmore East HS for the concert band. Drew Benware will conduct the chorus.

## **Old Business:**

CCMEA / NLAOSA workshop — survey results were presented by Cherie - see below. The new plan is to schedule the workshop tentatively for Saturday September 26 at AuSable Forks Elementary free of charge if we do our own clean up (i.e. garbage). The date was submitted by the clinician. Just Brian Hiller will be coming. He will charge \$50 less for being a solo clinician. Cherie has repeatedly contacted AOSA and has received no response from them regarding Northern Lights status. There is no money left in the NLAOSA account.

Survey: very few responses were returned from the survey Cherie sent out. Approximately 15 people are able/willing to attend. If we charge \$25 per person, we won't come close to cover expenses. Even if 30 people come we won't cover fee, hotel, travel, etc. total estimate for clinician is \$1400, with possible \$375 in income. Cherie is willing to put effort if we think it is worth the time. Advertise to professors at Crane in hopes of attracting college students.

The suggestion arose for the county to cover clinician fee (half) and the rest would come from profits. We would really like to generate more interest. Franklin and Essex counties would not be willing to help with expenses. There is interest from St. Lawrence county. Do we want to give it more time in order to advertise and get more interest? Would October be better? February? April? Discussion concluded for the time being.

Mike Nystoriak went to Joe Sugar day. Ideas were discussed, such as forming a government relations committee. Penny has agreed to chair the Government Relations Committee (i.e. stalk facebook). Brian emailed Lori Orestano James (person we have talked about before). If you are intersested, see/email/facebook Penny.

Mike wants to give someone a NYSSMA award - tabled until Sept.

Mike also brought up forming a Curriculum National Standards Committee. Carolyn is nerdy like that and will be elementary representative on the committee. Anyone else interested contact Brian. Would like representatives from different teaching areas (instrumental/high school/etc.).
